The ToolBank loans tools to other Non-Profits through the collection of dues and handling fees to assist them in completing their community improvement projects in a cost-effective manner. In addition to revenue received from tool lending and program service fees, the ToolBank receives donations from individuals, corporations, and foundations primarily located in the metropolitan area of Atlanta, Georgia.

The Tool Training Center (ITC) is located in the ToolBank. As an educational force for service, the ToolBank's Tool Training Center is helping our non-profit community make volunteer service easier, safer and more abundant across metro Atlanta. The ToolBank is now equipping volunteers with the knowledge of how to use tools more effectively, increasing volunteer skills and their impact on our community.
